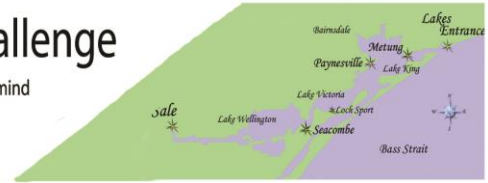

## TERMS AND CONDITIONS

1. All Entry Forms must be completed and returned together with the applicable entry fee. Entry into the Challenge will be deemed acceptance of these Terms and Conditions.
2. All information supplied to Sale to Sea Inc. will be kept strictly confidential and will only be used in relation to your entry into the Sale to Sea Disability Kayak Challenge and to keep all Medical Personnel aware of any special needs that you may require.
3. All participants must sign the Waiver accompanying this Terms and Conditions and Entry Form.
4. All participants must attend all pre-challenge briefings conducted prior to the Challenge. This briefing is held to discuss predicted weather conditions and any medical or emergency response procedures that may be required throughout the Challenge. Failure to attend this briefing may lead to your exclusion from the Challenge.
5. Challenge officials may at any time during the Challenge at their absolute discretion direct a participant's withdrawal from the Challenge. If an official directs a participant's withdrawal, the participant must comply with this direction immediately. Participants agree to indemnify Sale to Sea Inc. against any loss or damage resulting from their failure to comply with this condition.
6. All participants must ensure that they present with the following safety equipment ("Mandatory Safety Equipment") on the day of the Challenge:
  - a. PFD – Personal Flotation Device
  - b. Suitable headwear
  - c. Sunscreen and insect repellent
  - d. Paddle leash and bilge pump
  - e. Spare paddle
  - f. Sufficient Hydration and fluids
  - g. Suitable eyewear
7. Any participant that does not present with Mandatory Safety Equipment will not be permitted to participate in the Challenge.
8. Participants will not be permitted to use "Sit on top" Kayaks.

9. Participants must supply their own kayaks and safety equipment as specified by Sale to Sea Inc..
10. Sale to Sea Inc. will not be responsible for any equipment that is hired by participants. By accepting these Terms and Condition, you will hereby release Sale to Sea from all liability for any damage or loss suffered with respect to any hired equipment.
11. Participants are responsible for all personal property and chattels on the day of the Challenge. Sale to Sea Inc. will not be providing minding tents or secured storage for participants' personal items.
12. Sale to Sea Inc. will provide basic ground support for water safety emergencies on the day of the Challenge.
13. Sale to Sea Inc. will not collect participants at the end of the Challenge or provide shuttle services to return participants to the starting line. Participants must organise their own collection services or accommodation.
14. Participants entering the Challenge must be physically fit and have undertaken adequate training for the event.
15. Aggressive and antisocial behaviour will not be tolerated. Any participant, support teams or spectators that are engaging in antisocial, aggressive, inappropriate or dangerous behaviour will at Sale to Sea Inc's determination (acting reasonably). be withdrawn from the Challenge and must immediately leave the event.
